1. Introduction

Welcome to the It Ain't Over Community ("we," "our," or "us"). We are committed to protecting your privacy and personal information in the highest level and most secure ways possible. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you use our website, mobile application, and related services (collectively, the "Community").

2. Information We Collect

2.1 Information You Provide

We collect information that you voluntarily provide when signing up, using and participating in our Community, including:

- Account information (name, email address, password, I.P. Address, & MAC Address)
- Profile information (profile picture, bio, location)
- Content you post (messages, comments, photos, etc...)
- Communication preferences
- Contact information

2.2 Information Automatically Collected

When you use our Service, we automatically collect:

- Device information (IP Address, MAC Address, browser type, device type)
- Usage data (pages visited, time spent, actions taken, content uploaded and shared)
- Location data (if permitted by your device settings)
- Cookies and similar tracking technologies
- Log files



3. How We Use Your Information

We use the collected information for:

3.1 Service Operation

- Creating and managing your account
- Providing customer and technical support
- Verifying Identity
- Sending administrative communications

3.2 Service Improvement

- Analyzing usage patterns
- Developing new features
- Troubleshooting technical issues
- Improving user experience

3.3 Communication

- Sending service updates
- Providing community newsletters
- Responding to your inquiries
- Sending promotional materials (with your consent)

4. Information Sharing and Disclosure

We may share your information with:

4.1 Service Providers

- Third-party vendors who assist in operating our Community
- Analytics providers



- Cloud storage providers

4.2 Legal Requirements

- In response to legal requests
- To protect your rights and ours
- To investigate potential violations
- To prevent harm or illegal activities

4.3 Business Transfers

- In connection with a merger, acquisition, or sale of assets
- During negotiations of any business transaction

5. Your Privacy Rights

- Access your personal information
- Correct inaccurate data

- Restrict processing of your information

We implement appropriate technical and organizational measures to protect your information, including:

- Encryption of data in transit and at rest
- Regular security assessments



- Access controls
- Secure data storage
- Employee training on data protection

7. Data Retention

We retain your information for as long as:

- Your account is active
- Needed to provide our services
- Required by law
- Necessary for legitimate organizational purposes

8. Privacy of Children/Minors

Our Community is not intended for children/minors under 18 years of age. No one under the age of 18 is permitted to access, create an account, sign in, use, or participate in the It Ain't Over Community. We do not knowingly collect information from children/minors under 18 years old.
